- c. The National Joint Council has agreed this year's Pay Award for Clerks and, as recommended by CALC and NALC it was resolved to pay the appropriate backpay and to amend the Standing Orders at the bank.

22/36 Reports:

Councillor Wearing reported on the following:

- a. Cost of living grants and their availability.
- b. CCC is supporting children with hot meals and organising a breakfast club to provide a hot meal during the daytime. It is hoped that the new Westmorland and Furness Council will continue this work next year.
- c. Obviously there will be no CCC Precept next year, when the new Authority is established.
- d. A meeting has been held with Cumbria Wildlife Trust regarding the provision of pollinators; there is £10,000 available for this work and schools need to be made aware of it.
- e. If grit bins are seen to be empty, please let CCC Highways know and they will fill them up. Grit pile requirements can be sent to Councillor Wearing too.

Councillor Holmes produced a written report and this will be appended to these minutes in the file. He mentioned the following:

- a. He had sent the Clerk information on septic tanks; this information is to try to reduce the discharge of waste into the lake.
- b. SLDC is currently very busy with the usual business, and also preparing for the new Westmorland and Furness Council from 1st April 2023.
- c. An upgrade to the Grange Lido is planned.
- d. Phase 1 of the new Leisure Centre in Ulverston.
